



Message from the President

Summer is coming to an end and children have returned back to school. As we prepare ourselves for the coming winter holidays, I am reminded it has nearly been two years since the restructuring of the hospital. Wow, how time flies. We are also quickly approaching election season. HPAE is endorsing Hillary Clinton for President and believes her policies and agenda are in line with our union. Are you registered to vote in the coming Presidential election, November 8, 2016? If you are not registered you still have time. In New Jersey you have until October 18, 2016 via mail and in-person to register to vote. "Change the world... vote."

During our last membership meeting on August 25, 2016, those in attendance received our new contracts. Items discussed were related to lack of administrative support, accountability and RNs still covering call-outs. Union reps have met with administrators and presented our signed petition (20 out of 25 RN') and have provided several suggestions. Administrators have been made aware that patient care is OUR FIRST PRIORITY. Nurses were asked to submit suggestions to union reps on how sick call coverage could be returned back to administration. Covering sick calls is outside of our contract and is considered non-nursing duty."

It was agreed by those in attendance at the membership meeting that **on-call supervisors would be notified of all sick calls and asked to advise on how to proceed.** Please be prepared with staffing sheets and inform administration of you unit's acuity, pending admissions, # of Q15 min precautions, number of patients needing hands on assistance with ADL's, etc. Patient care suffers when you have to spend hours on the phone to find available staff. **Administrators should make all staffing decisions.** Have them make the decision on who is called (RN or IA) and if someone is called. Again, OUR position is that this is a "NON-NURSING DUTY," and was a task performed by administration prior to selling of the nursing home units and should continue to be an administrative duty.

The September 7, 2016 Labor Management meeting was cancelled by Cornerstone Administration.

Please hand in your surveys to Elaine, Cindy S or Priscilla. Your completed surveys are needed so we can serve you and your needs and collectively be a better union. Please contact Priscilla for copies of your newly printed contract.

Lastly, we have been chosen by HPAE to pilot text messaging. Using this technology will enable our local to communicate more efficiently, keeping you, the membership, informed about patient issues and actions.


