LABOR-MANAGEMENT COMMITTEE 9/18/19

The Labor-Management committee was introduced to the new Operation’s Director, Rick Smiley. We provided Mr. Smiley with a tour of the proposed break areas on Cornerstone East, (nursing lounge and the activity storage/closet) as well as reminded him of the County’s contractual obligation to provide a dedicated area for members to take their break and/or lunch in a sanitary and safe area. We expressed our concern, yet again, that staffing on both units continues to be done in accordance with the census as opposed to the acuity of the patients. We also discussed the need to ensure that we have the necessary tools available to ensure that we can provide safe, quality care to our changing population (i.e. Geriatric Psychiatry and medical co-morbidities). Lastly, we addressed the many payroll issues that continue to persist however we were unable to reach a resolution and have escalated these matters to the County Administrators.

VIOLENCE PREVENTION COMMITTEE 9/23/19

Restraint incidents and injuries were reviewed with 1 minor injury since the last quarter. A commitment was made to make the committee more proactive to reduce violent incidents as opposed to reactive in the upcoming year. Wendy E., RN was missed and has been an asset to this committee. Lastly, we were advised by the County that the wage increases are tentatively scheduled to go into effect in the November 15th paycheck. In addition, the County is also in the process of calculating the retroactive monies owed since the ratification of the contract and have not provided HPAE with a date for distribution as yet. HPAE will continue to monitor this issue and commits to providing updates as the information develops.
