The Nominations/Election Committee announces that they are now accepting nominations to represent Local 5621 at this year's HPAE State Convention. **HPAE State Convention**

The Local is entitled to nineteen (19) delegates and five (5) alternates based on their membership. This year's convention will be held virtually, October 7, 2021. Local 5621 Constitution and By-Laws states that all elected local officers are delegates to the convention. There are five (5) elected officers, which mean that fourteen (14) delegate positions and five (5) alternate positions are open for election. All expenses are the responsibility of the delegate or alternate. Some reimbursement from the Local maybe available. Any available money will be shared equally among delegates attending. The nomination/election committee is currently accepting nominations for these positions.
