#### HOW DOES RAPID RESPONSE HELP?

#### By helping you...

- Navigate Unemployment Insurance (UI)
- Get started on your job search and understand available support
- Understand available educational and training opportunities

# UNEMPLOYMENT INSURANCE



#### WHEN CAN I FILE

#### The first day you are officially unemployed

- Unemployment Insurance weeks run Sunday Saturday.
- If you worked a full week, file the beginning of the next week (starting online on Sunday).
- If you worked a partial week, file once you are separated.

#### **ABOUT YOUR CLAIM**

- All unemployment claims begin on the Sunday of the week in which you filed.
- It is your responsibility to file promptly after your layoff.
- Unemployment benefits are not retroactive, and you will not be paid for weeks prior to the date you filed.
- If you miss your filing day and fail to file within the 7-day period, you may lose your benefits for the week you did not file.

#### **BEFORE FILING**

#### Make sure you have...

- Name, address and telephone number of all employers for which you worked – the past 18 months
- Driver's license, Social Security number and alien registration number (if not a US citizen)
- Union information: local number & address
- Start/end dates for all jobs in last 18 months for job separation.

#### WHEN FILING A CLAIM

- Consider having federal taxes (10% flat tax) withheld from your unemployment benefits and forwarded to the Internal Revenue Service (IRS). This will help offset your tax liability, since unemployment benefits are subject to federal income taxes.
- Be ready to provide your bank account information (bank routing number and account number), if you wish to be paid via direct deposit.

## **Consider payment options**

#### **Direct Deposit**



Have your benefits deposited directly into your checking or savings account.

#### **Debit Card**



Get cash from surcharge-free in-network ATMs Nationwide that carry the **AllPoint** or **MoneyPass** brands. To find surchargefree in-network ATMs, use our ATM locator found at **mbd.everywherepaycard.com** or in the Money Network Mobile App).

# File online

Visit myunemployment.nj.gov

- To file online for New Jersey UI, you must:
- Have worked in NJ for the past 18 months
- Have an email address
- Have earned at least some of the wages in New Jersey

## ONLINE (cont'd)

- When filing online, you will need to create your Single Sign On account. This requires an email address that you can access when creating your account.
- Your Single Sign On account will provide access to your UI Dashboard after your claim is filed. Whether filing online or via phone, your online UI account information is available to you.

## **ELIGIBILITY & UI DETERMINATIONS**

# To be eligible for UI benefits, you must meet one of the following requirements:

- You must have worked at least 20 base weeks; or
- You must have earned \$13,000 during your base year period.

#### What's a "base week"?

• A base week is any week of work where you earned at least \$260 during a 52-week period (base year) in covered employment.

#### ELIGIBILITY (cont'd)

#### What's a "base year"?

• A base year comprises the first 4 calendar quarters of the last 5 completed calendar quarters before the date of the claim.

#### What's "covered employment"?

 Covered employment means services performed by an individual for pay, unless specifically prohibited by unemployment law or regulation.

# Your regular base year consists of 52 weeks. It is determined by the date of *your* claim.

#### **ADJUDICATION**

 If any issues are identified which may impact eligibility, the matter will be referred to a Claims Examiner who will make a determination on eligibility for benefits.



#### **ADJUDICATION** (cont'd)

- For claims filed online, when an issue is identified you will be emailed a link for your issue. Clicking the link will bring you to a questionnaire that upon completion will be sent to a Claims Examiner for a determination (known as E-Adjudication).
- Claims filed by phone will be scheduled for a phone hearing 3-5 weeks from when the claim is filed.

#### **BENEFIT RATES**

#### Maximum weekly benefit rate for 2023 is \$830.

• To receive the *maximum*, one must have earned an average of \$1,383.00/week or approximately \$71,916.00/year.

If you don't qualify for the maximum weekly benefit rate, you may qualify for **dependency benefits** if:

- Your spouse or civil partner is unemployed the first week you file; or
- You are a single parent with dependent children.

#### CALCULATING YOUR UI BENEFITS

- Your total benefits are based on earned wages and the number of weeks worked (one week of UI benefits for each base week worked, up to 26 weeks).
- If you worked less than 26 weeks during the base year, your benefits will reflect your actual number of weeks worked.

## CALCULATING YOUR UI BENEFITS (cont'd)

- Your benefits are 60% of your average weekly before-tax wages during the base year (up to the maximum weekly benefit rate).
- Tools to assist with estimating your benefit rates can also be found at myunemployment.nj.gov

### PAYMENTS THAT DO NOT AFFECT YOUR BENEFIT

- Severance (in most cases) or bonus pay
- Vacation, sick, or holiday pay
- Social Security benefits
- Pension payments from an employer(s) outside your base year

#### CAUTION: PAYMENTS THAT DO AFFECT YOUR BENEFITS

- Taking cash out of a 401k retirement or qualifying pension while collecting UI will reduce benefits.
- Withholding the 10% federal tax will reduce payments now.

#### CAUTION: PAYMENTS THAT DO AFFECT YOUR BENEFITS (cont'd)

- If your employer is required to give you notice, but instead gave "payment in lieu of notice" or "continuation pay," you must wait until payments end to file.
- If receiving any type of separation pay, don't wait to file your claim.
  File immediately and let UI decide on your eligibility. Remember claims are not back dated, so if you wait that period will be lost.

#### **WORKING PART-TIME**

- If you work part-time while claiming benefits, your gross earnings will be deducted from your "partial weekly benefit rate" (PWBR), which is 20% higher than your weekly benefit rate.
  - Example if your WBR is \$400/week, your PWBR is \$480/week. Any p/t earnings are subtracted from \$480, making your total income for the week \$480 instead of \$400. (Note you can never be paid more than your WBR, so if earnings are \$50 in this example, you will be paid \$400 from UI.)
- If collecting partial benefits, while your total income will be higher each week, your UI benefits will be reduced by a smaller amount which extends how long you can collect your total benefits.

#### WORKING PART-TIME (cont'd)

- Important to remember to report all earnings when you actually work, not when you get paid
- Failure to report earnings while collecting unemployment benefits is fraud. The Division of Unemployment Insurance runs crossmatches with employer payrolls quarterly and if you work while collecting benefits, you must pay all benefits collected back, plus fines and interest, as well as the possibility of being ineligible for benefits for one year.

#### **AFTER YOU HAVE FILED**

- Go to myunemployment.nj.gov to sign into your account. This will allow you to view your claim information (Weekly Benefit Rate, Balance, last week paid), as well as certify for your weekly benefits. You can also manage your claim, access your 1099, etc. from there.
- Be sure to check the email you provided for important information and updates.

# CLAIMING BENEFITS



## **CERTIFYING & CLAIMING YOUR BENEFITS**

#### FIRST TIME claiming benefits—

- The first time you get paid will be the Wednesday of the third week after your claim is filed. Payment will be for the first two weeks.
- On Wednesday in the 3rd week of the claim, certify and claim your benefits via phone or online.

#### Example—

You file a claim the week of January 29<sup>th</sup>, 2023 (claim dated Sunday, 1/29/2023). Your first weeks of payment will be for the weeks-ending 2/4/23 and 2/11/23. You would claim payment for those two weeks on Wednesday 2/15/2023.

## CLAIMING YOUR BENEFITS (cont'd)

#### After the first payment, *claim*:

- Online: Weekly starting Sunday of each week, or any day of the week
- By phone: Weekly or bi-weekly Monday through Friday

Base your selected call-in day by the last digit of your Social Security number.

- If your SS # ends in an odd number, claim on Monday.
- Even numbers, claim on Tuesday
- Wednesday Friday calls: ANYONE

#### **CERTIFICATION QUESTIONS**

- 1. Are you able and available for work?
- 2. Are you actively seeking work?
- 3. Did you refuse any work?
- 4. Are you attending school or job training?
- 5. Did you work during the week(s) claimed?
- 6. Did you perform any commission or self-employment work, or were you entitled to holiday or vacation pay?
- 7. Are you receiving or have you applied for pension or other retirement pay (not including Social Security benefits) from an employer in your claim?

#### **REMAINING ELIGIBLE**

- You must be able to work, available for work, and actively seeking employment.
- Actively seeking work under UI rules requires that you make at least one verifiable work search effort for each week you claim benefits.
- You may be asked to provide documentation proving your job search efforts, so keep records.
- Claim your benefits weekly or bi-weekly, either online (Sunday – Saturday) or by phone (Monday – Friday).

#### JUST TO RECAP

- File as soon as you become unemployed.
- Watch your mailbox for paperwork stating your weekly benefit rate (WBR), and when to claim your first benefits payment.
- Check emails regularly for messages from the NJ Division of Unemployment.
- Continue to claim your unemployment benefits until you become reemployed or run out of benefits.

- **Tuition Waiver:** Tuition-free courses at NJ state or county colleges for the unemployed
- Training Grants: Funding for those lacking essential skills, key credentials or training
  - Note: Clients receiving Unemployment Insurance, may be eligible for Additional Benefits during Training, or ABT's if UI claims expire before training has completed. Meet with a Training Counselor to discuss.

#### **JOB SEARCH & PLANNING WORKSHOPS**
