AFT NATIONAL CONVENTION

The Local has voted to elect two (2) delegates and two (2) alternates to attend this year's convention which will be held at George R Brown Convention Center, Houston, Texas, July $22^{nd} - 25^{th}$, 2024. Local 5621 Constitution and By-Laws states that all elected local officers are delegates to the convention and would be the ranking delegates.
