Pursuant to a letter of agreement with the Health Professionals and Allied Employees, Local 5094, hereinafter referred to as “Local 5094,” the American Arbitration Association, hereinafter referred to as the “Administrator,” agreed to conduct an Election of Officers.

Rutgers Newark - 36


Prior to the count One (1) Rutgers Newark envelope was set aside and not counted as the voter did not appear on the list of eligible voters for Rutgers Newark.
