NOMINATIONS PROCEDURE:	<p>A member in good standing may nominate another member in good standing to be a candidate for office by submitting a nomination form by the nomination deadline. The form must include the candidate’s signature accepting the nomination, including the last four digits of the candidate’s social security number as verification. Forms without the candidate signature and verification will not be accepted. Typed signatures will not be accepted. A member may only nominate one candidate for the same position, and a member may not be a candidate for more than one position. Members may self-nominate.</p> <p>Completed forms must be returned to Local 5185 Nominations and Elections, P.O. Box 119, Emerson, New Jersey 07630 or emailed to elections@hpae.org. Candidates are encouraged to confirm receipt of the nomination from before the deadline by emailing elections@hpae.org.</p>

NOMINATIONS DEADLINE:	Form must be received no later than October 31, 2025 . Forms received after this time will not be accepted. No exceptions.

ELECTION INFORMATION:	<p>Candidates must abide by the HPAE local election rules, which can be viewed here: www.hpae.org/resources/electionrules. Ballots will be mailed to all members on November 10, 2025. An unopposed candidate shall be deemed elected and ballots for that position will not be mailed to members.</p> <p>Candidates may submit campaign statements, which will be posted on the local webpage. Statements are due by November 7, 2025, 5:00 pm. Statements should be five hundred (500) words or less and submitted in electronic form to elections@hpae.org. A campaign photo may be submitted.</p> <p>Electioneering on the following platforms or venues is strictly prohibited: Union’s Facebook or other social media platforms, Union bulletin boards, union premises, union meetings. This does not bar candidates from campaigning on their own social media sites.</p>
